A deposit is required to reserve a kitten and is strictly non-refundable. Remaining balance must be paid prior to pickup or delivery. Failure to complete payment may result in forfeiture of deposit and cancellation of sale.

#### 3. INITIAL HEALTH GUARANTEE (72 HOURS) — Buyer Initials: \_\_\_\_\_

Buyer agrees to have the kitten examined by a licensed veterinarian within 72 hours (3 business days). Failure to do so voids all guarantees.

If a serious or life-threatening illness is diagnosed within this time and verified in writing, Seller will provide a replacement kitten of equal value.

**4. INFECTIOUS DISEASE DISCLAIMER — Buyer Initials: \_\_\_\_\_**

Seller is not responsible after 72 hours for FeLV, FIV, FIP, parasites, or infectious diseases, as these may be contracted after leaving Seller's care.

Buyer agrees to quarantine the kitten for a minimum of 7 days.

**5. GENETIC HEALTH GUARANTEE (1 YEAR) — Buyer Initials: \_\_\_\_\_**

Seller guarantees the kitten against hereditary defects including HCM for one (1) year.

Requirements include written veterinary diagnosis and necropsy if death occurs. Seller may request a second opinion.

Remedy: Replacement kitten only. No refunds or reimbursement.

**6. FIP & VACCINATION POLICY — Buyer Initials: \_\_\_\_\_**

Buyer acknowledges Feline Coronavirus is common and may mutate into FIP. Seller cannot guarantee prevention.

If death occurs within 6 months due to confirmed FIP, necropsy, histopathology, and documentation are required.

Buyer agrees to consult veterinarian regarding vaccinations and understands risks of modified live vaccines. Seller is not responsible for vaccine-related outcomes.

**7. BUYER RESPONSIBILITIES — Buyer Initials: \_\_\_\_\_**

Buyer agrees to provide proper veterinary care, nutrition, and indoor housing. Failure to provide adequate care voids all guarantees.

**8. SPAY / NEUTER AGREEMENT — Buyer Initials: \_\_\_\_\_**

Kitten sold as pet or show will be altered prior to leaving Seller, unless otherwise agreed upon in writing.

If breeding rights are not granted, the kitten will be spayed/neutered.

Buyer agrees to provide proof of spay/neuter from a licensed veterinarian (including invoice, clinic name, and date of procedure) within 7 days of surgery.

Failure to comply with any portion of this section will result in a \$1,000 fee and will be considered a breach of contract.

**9. DECLAWING PROHIBITED — Buyer Initials: \_\_\_\_\_**

Declawing is strictly prohibited and voids all guarantees.

**10. RETURN POLICY — Buyer Initials: \_\_\_\_\_**

If Buyer cannot keep the kitten, it must be returned to Seller. No refunds will be issued. Kitten may not be surrendered or rehomed without approval.
