- The Stud is properly housed and cared for during the breeding period.

4. BREEDING TERMS

- The Queen will be delivered to the Stud owner on or about: _____

- The Stud owner will provide adequate care, food, and housing during the stay.

5. PREGNANCY VERIFICATION

- Pregnancy verification will be conducted via ultrasound before the Queen is returned to her owner.

- The results of the ultrasound will be accepted by both parties as confirmation of pregnancy status at the time of examination.

6. CARE AND LIABILITY

- The Stud owner agrees to take reasonable care of the Queen but shall not be held liable for illness, injury, escape, or death beyond their control.
- The Queen owner assumes all risks associated with breeding.
- Any veterinary costs incurred during the Queen's stay will be the responsibility of the Queen owner unless otherwise agreed.
